The Inside Perspective:

Reflections from The Nonprofit Partnership staff

In reflecting on the big themes that have emerged from a turbulent 2012, two revelations stand out:

- » Nonprofits everywhere are finding it necessary to compete for business in the market economy. Why? More and more of our revenue is earned because customers choose to do business with us. This growing trend emphasizes the importance of sustaining service quality, measuring impact, and telling your organization's story through a compelling marketing plan.
- » Government's retreat puts more emphasis on our role as advocates for our clients and the larger community and forces us to rethink and retool our strategies and business plans to survive and thrive in the years ahead.

While the larger community has come to know and value The Nonprofit Partnership's role in offering education and training for nonprofit leaders through workshops and conferences, many may be less aware that we are also assisting our member organizations in measuring up to the big challenges of our time through consultation and facilitation in focused work with management and board leadership. The profiles below offer a peek inside this work and illustrate how The Nonprofit Partnership staff is adapting its programming so that nonprofits in our region have the leadership, vision, marketing tools, and sustainability strategies they need to be strong and competitive in 2013 and beyond.





Our Work with Boards

The governing board is the source of vision for the organization and the engine that drives organizational strategy, but many boards struggle to reconcile their missions with the reality of a competitive, fast-changing environment. Some have not yet built or have neglected their infrastructure, others are asking for guidance and support as they make their transition from all-volunteer status to their first paid staff, and still others are working to convert outdated strategic plans into strategies for sustainability.

Over the past year, The Nonprofit Partnership has helped boards in each of these stages move past a barrier and enter a new phase of governance:

- » The all-volunteer Erie Women's Fund and Cystic Fibrosis Association of Erie County found that by updating their by-laws and re-organizing their operations they were poised to be more effective in pursuing their missions.
- » Other all-volunteer organizations including the Fairview School Foundation and The Upper Room of Erie worked through the challenges of growth by using consultation from The Nonprofit Partnership to move toward hiring their first paid employees and making the transition from a working board to a governing body.
- » Many mature organizations found themselves trapped inside irrelevant strategic plans that needed to be updated and tuned up to become sustainable business models. L'Arche Erie, Mystic Mountain Training Center, and the Mental Health

Association of Northwest PA, among others, used facilitated board retreats with The Nonprofit Partnership to re-shape their plans and craft innovative new visions for the future.



Communication Makeovers

Because much of a nonprofit's

revenue is driven by the market economy, a sound marketing strategy is the foundation of success for any nonprofit organization. When marketing efforts are fragmented and not consistent among different communication channels, the NPP Communications Makeover package of services helps to correct this inconsistency and provide the nonprofit with a cohesive strategy that includes both online and offline marketing vehicles. Over the past year, The Nonprofit Partnership's Communications Makeover project has helped a dozen organizations in their quest for consistent branding and marketing, but one that stands out is the Erie United Methodist Alliance (EUMA).

Although the project began with a request for a website upgrade, our needs assessment showed the need for a more solid, memorable brand for the organization. Focus groups formed the basis of a branding study, which helped to refine a positioning statement, mission statement, and tagline, along with a marketing plan to ensure the success of the new brand. Working with a local design agency, EUMA generated a new website that was consistent with the new brand and portrayed a more updated, modern look for the organization. In addition to the new website, a PowerPoint presentation, updated social media presence, print pieces, a story database, and an e-newsletter were established to allow the new brand to grow.

Cheryl Davis, Executive Director, and Kate Hiles, Development Director, have a bright new outlook for the future and a solid foundation on which to build their organization's new image. "We were thrilled to be chosen for the communications

makeover program through the Nonprofit Partnership. Our organization had reached a point that our marketing/branding program needed to be addressed. The program through the Nonprofit Partnership made this all possible. They have worked closely with us in the last year to identify our needs, map a comprehensive program and guide us through the entire process. Through Bob and Amanda's expertise and professionalism, we have achieved



a greater understanding of marketing/branding concepts which has given us the confidence to move forward with a greater capacity to connect with our audience and the community at large."



Nonprofit Leadership Peer Circles

A growing wealth of evidence is pointing to peer learning circles, coordinated with individual coaching, as one of the most effective ways to build leadership strength at the highest levels in an organization. Nonprofit executives, grantmakers, and industry thought leaders are all endorsing this approach as one that encourages the sharing of relevant information, reduces isolation, and

offers one-to-one coaching that leads to personal growth and organizational change. In 2012, NPP hosted a Peer Circle for member Executive Directors. The Circle met once a month for three hours and offered its eight participants an opportunity to share, to build skills, and to develop a strong peer network.

Dave Robinson, Executive Director of the Union City Family Support Center, offered this assessment of the value of the Circle: "By joining the Leader Circle, I've developed relationships with peers that I believe will last a lifetime. The insights which come from regular connections with others in the same position and facing the same struggles are a huge benefit.... Being a part of this Circle turned me around on issues I thought I was firm on, such as boards and their role in the success or failure of the organization. Through other Circle members, I see how boards succeed based on how well they're staffed, so carving out more time for board development is vitally important and is something I'm now committed to as a result of the Circle. At minimum I've doubled the time I spend personally interacting with my board members."

Audrey Szychulski, Executive Director of the Erie Philharmonic, cited the Circle's effectiveness in reducing isolation given the well-known "it's lonely at the top" conundrum faced by CEOs everywhere. "As a Director, you feel the burden of a whole organization and feel pressure to make sure everything is working well. The Leader Circle allows me to 'let go' and share some of that burden. As a group there was this wonderful sense of acceptance and welcoming and comfort in knowing that you're not the only one feeling this way (about a problem).... We started as a group of peers, but as we went along we became a group of friends."

About The Nonprofit Partnership

Capacity-Building Grants

The purpose of The Nonprofit Partnership's grantmaking in the area of nonprofit capacity-building is to offer timely, effective, professional assistance to local organizations as they seek to build their organizational capacity and address the critical issues of quality and effectiveness. Grants in this arena typically range from

\$5,000 - \$15,000 and focus on the following capacity-building dimensions:

- 1. Mission, Vision, and Strategy
- 2. Leadership and Board Development
- Strategic Relationships and Alliances
- 4. Internal Operations and Capacities
- 5. Website Development



Service grants in the form of communications makeovers focusing on website enhancements, online communication tools, and annual reports are also offered to develop the marketing capacity of member nonprofit organizations, and short, story-based, campaign-oriented videos help members capture and disseminate their compelling messages coupled with calls to action that generate results.

Education and Training

A cornerstone of The Nonprofit Partnership's annual menu of offerings to members, open-enrollment education and training sessions feature a variety of experts on management, governance, fundraising, accountability, and marketing who present topics in a variety of formats and venues to build members' skills and capacities to run effective, high-quality organizations. These education and training activities are at the heart of the partnership's mission because they are the primary vehicles for building relationships with member organizations as well as for the transmission of information and the building of skills that are used by member agencies each year. Our offerings include:

- » Two hour morning workshops based on high-interest, in-demand topics.
- » Full-day Learning Circles like The Story Project where nonprofit leaders work in teams to capture and record the emotionally laden stories at the root of their transformational work
- » Northwest Pennsylvania Nonprofit Day Conference
- » Collaborative education programs involving content experts that assist nonprofits with skill development in specific mission-critical areas.
- » Online content packages that reinforce workshop material while facilitating access to training resources for members who are more geographically distant.



Board, Leadership, and Organizational Development Activities

The Nonprofit Partnership facilitates peer education circles for organizational leaders. Separate small groups of Executive Directors, Development Directors, and Board Chairs meet monthly to discuss challenges, integrate best practices, and reduce their isolation as they pursue their individual effectiveness goals with guidance, resources, and peer support.

The Nonprofit Partnership also trains participants in Project Blueprint, a program that prepares a diverse set of leaders for volunteer and Board service with nonprofits in Erie County. Participants are recruited from neighborhoods and businesses throughout Erie and attend leadership development and governance training prior to being matched with organizations that align with their service interests and skills.

Consultants from The Nonprofit Partnership are available to plan and facilitate Executive leadership development sessions, Board retreats, strategic planning sessions, focus groups, advocacy training, and outcomes and evaluation training, all essential ingredients of organizational effectiveness.

In partnership with the United Way of Erie County, The Nonprofit Partnership is boosting the level of volunteerism in Erie County through the Get Connected online volunteer portal, a website that matches agency needs with the supply of community volunteers. We are also hosts to the Erie-based leader of the Lake Effect Leaders, AmeriCorps*VISTA's regional program which generates thousands of volunteer and service hours annually to build host agency capacity to boost educational outcomes for youth and reduce poverty in northwest Pennsylvania.

The Nonprofit Partnership can also be instrumental in helping nonprofits access Pro Bono legal and accounting services on a case-by-case basis, and as staff to the Erie Community Fund Drives Committee, we offer technical assistance in the design of capital campaigns.
